Following significant funding and failure to meet subscriber levels the company took steps to reshape its cost base which ultimately proved unsuccessful. Peter and his team assisted the joint venture partners after the collapse of the business.
- Project Wire: Peter advised the bank syndicate of this global connectors manufacturer to review its strategy and capital structure. Our role included commenting on the relocation of some of the Group's businesses to other countries to reduce the Group's cost base. Following our review and advice the banks were able to negotiate revised facilities for the Group.

Despite the insolvency of the group and acting in the capacity as joint administrator and provisional liquidator of the Group's key companies, Peter was successful in maintaining trading across the globe to enable the financial and operational restructuring and subsequent sale of the subsidiaries in most countries in which the group operated.
- Project Orbit: Global satellite broadcasting. This non-profit making organization required additional funding to support its re-organization and growth during its transition to a fully commercial company. Peter led the assignment for the banks which included an

assessment of the potential value in the underlying business and assets and a review of the overall business plan. The organization obtained restructured financing enabling it to implement its planned changes leading to profitable trading.

- Drax: As part of the team advising the bank syndicate in Europe's largest coal fired power station, Peter provided advice relating to the Group's ultimate restructuring.
- Global Crossing: Peter provided advice to the secured bank syndicate of the global telecoms provider in respect of the restructuring of the Group's European assets.
- Project Chippy: The assignment, headed by Peter, included an analysis of the group's present financial position and funding requirement over the following 18 months period, together with a Rapid Performance Improvement Review. This led directly to the group obtaining additional funding and improving its product margins.
